

The Points of Single Contact have grown out of the Services Directive with the goal of facilitating service provision within the European single market. In Mecklenburg-Vorpommern, the Points of Single Contact support both start-ups and existing businesses in order to strengthen our region as a business location.

- Round-the-clock applications using an electronic application wizard at www.ea-mv.de
- Assistance with registrations, re-registrations and de-registrations under the Trade Act and the Trades and Crafts Code
- Co-ordination of necessary official approvals and permits by the Point of Single Contact
- Close co-operation between the contacts and the responsible authorities
- Save time through electronic procedure and direct access to forms
- Monitoring of compliance with deadlines



Of course the Points of Single Contact will only work on your behalf, if requested.

- Advice and information about the requirements, procedure and formalities for taking up and exercising a service activity.
- Information about access to public registers and databases as well as likely costs.
- Provision of information about legal options when dealing with the authorities. However, for legal reasons, this information is not a substitute for detailed legal advice.
- The Point of Single Contact can provide information or put you in touch with the right people in areas such as financial, health, social and transport services procedures as well as tax and employment law procedures and building law.
- Round-the-clock use of the range of electronic information on offer.
- The co-ordinating activities are available to all EU and German citizens.
